

PRIVACY NOTICE AND CONSENT FORM

You hereby acknowledge that you have been provided with the written notification below on your rights as a Data Subject in accordance with the Data Privacy Act of 2012 as follows:

- i. to be informed whether Personal Data and/or Information is being or has been processed;
- ii. to require Wisefund to correct any Personal Data and/or Information relating to the Data Subject which is inaccurate;
- iii. to object to the processing of the Personal Data and/or Information in case of changes or amendments thereon as supplied or declared;
- iv. to access the Information and/or Personal Data; and
- v. to suspend, withdraw, block, remove, or destroy the Data Subject's Personal Data and/or Information from Wisefund information database system.

Throughout the processing of your "Personal Information", your rights under the Data Privacy Act of 2012, such as the (1) right to be informed, (2) right to object, (3) right to access, (4) right to rectification, (5) right to erasure or blocking, and (6) right to damages, shall be upheld.
